

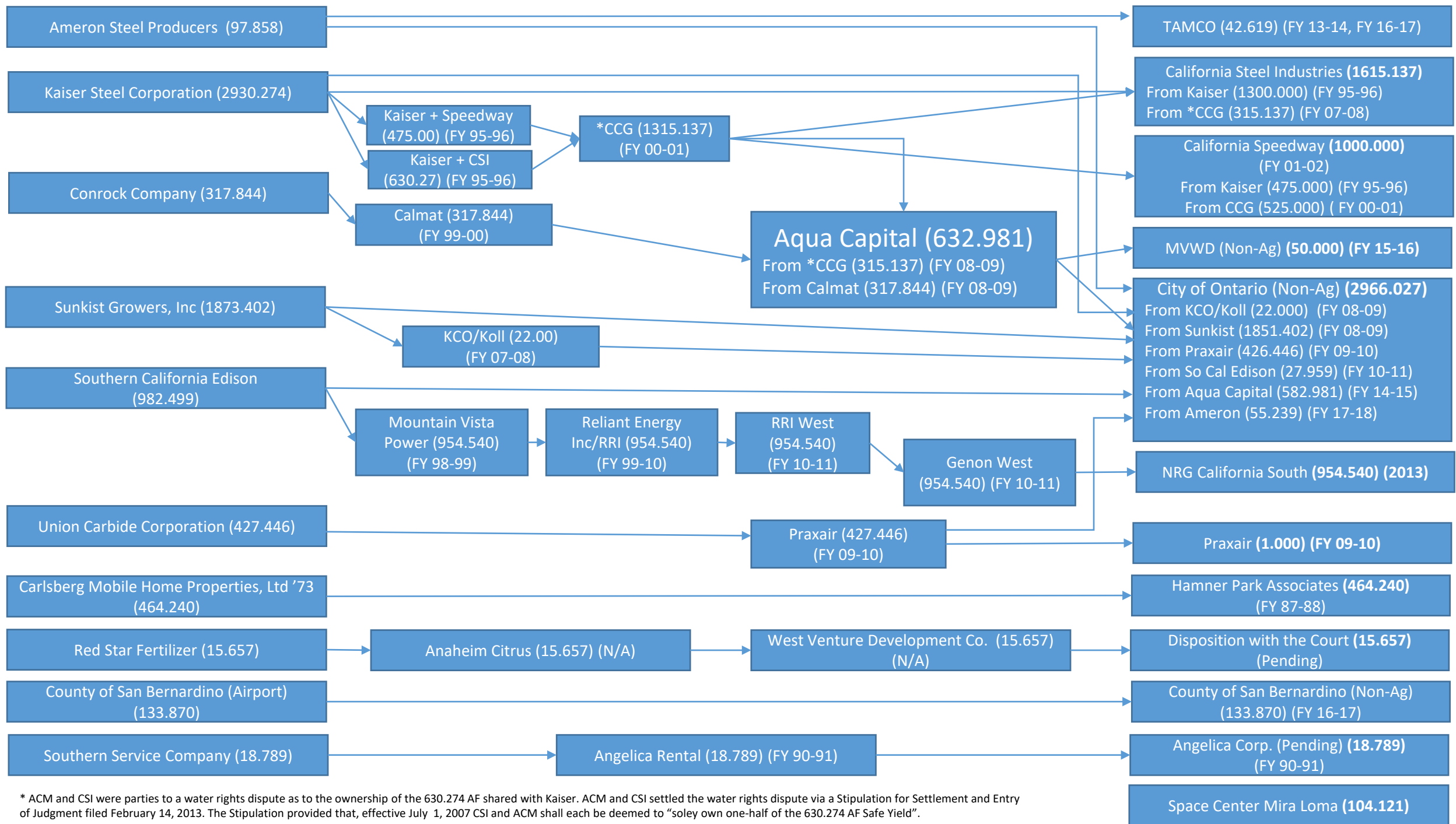

|                               | <p>Kaiser, among other things and as more specifically defined in the Agreement and Water Rights Acknowledgment attached thereto, permanently transferred 1,300.000 AF SY to California Steel Industries, Inc. (“CSI”). Kaiser and CSI also agreed to jointly hold 630.274 AF of Kaiser’s SY allocation with agreed priorities amongst the two parties. On December 20, 1995, the Court entered an order approving a stipulation, which included the Water Rights Agreement and other terms, between Kaiser and CSI.</p> <p>Pursuant to the Water Rights Agreement dated November 21, 1995, Kaiser transferred 475.000 AF SY to California Speedway Corporation (previously Speedway Development Corporation) to be held as tenants in common with Kaiser and subject to agreed priorities amongst the parties.</p> <p>In FY 00-01, Kaiser permanently transferred the remainder of its interests in SY to CCG Ontario, LLC. As described in a July 19, 2001 Court order, these rights included 525.000 AF SY, 475.000 AF SY held as tenants in common with California Speedway Corporation and 630.274 AF SY held as tenants in common with CSI, with agreed priorities amongst the parties.</p> <p>In FY 00-01, CCG Ontario, LLC permanently transferred its 525.000 AF SY to California Speedway Corporation.</p> <p>On December 28, 2008, the Watermaster Board approved a permanent transfer by CCG Ontario, LLC to ACM of the 630.274 AF SY CCG Ontario held jointly with CSI to ACM. Thereafter, ACM and CSI were parties to a water rights dispute as to the ownership of the 630.274 AF SY CSI shared with Kaiser. ACM and CSI settled the water rights dispute via a Stipulation for Settlement and Entry of Judgment filed on February 14, 2013. The Stipulation provided that, effective July 1, 2007, CSI and ACM shall each be deemed to “solely own one-half of the 630.274 acre feet of Safe Yield” or 315.137 AF of SY each.</p> <p>In FY 14-15, ACM owned the Conrock rights, as described above, and the Kaiser Steel Corporation rights.</p> <p>On July 24, 2014, the Watermaster Board approved a permanent transfer by ACM to City of Ontario (Non-Ag) of 300.000 AF SY.</p> <p>On June 25, 2015, the Watermaster Board approved a permanent transfer by ACM to City of Ontario (Non-Ag) of 282.981 AF SY.</p> <p>On July 23, 2015, the Watermaster Board approved a permanent transfer by ACM to Monte Vista Water District (Non-Ag) of 50.000 AF SY.</p> | <p>City of Ontario (Non-Ag) (265.137 AF),<br/> Monte Vista Water District<br/> (50.000 AF)</p> |

After subdividing and selling the property, West Venture disclaimed any interest in the water rights, requesting that their disposition be determined by the Court.
