Those actions were taken contrary to the provisions and requirements of the Judgment and the Rules and Regulations of the Chino Basin Watermaster.

Accordingly, Fontana Water Company urges the Court to issue an order declaring that the costs of the audit of Watermaster Services are not properly a Watermaster expense and that the costs should be borne entirely by the Chino Basin Municipal Water District.
