22 PLEASE TAKE NOTICE THAT, on April 14, 1997, in Department H of the above-
23 entitled court, the Ex Parte Application of Monte Vista Water District for an Order Striking
24 the Reply to Opposition to Motion for Appointment of a Nine-Member Board as Water-

12 cause to be heard on April 29, 1997, is extended until April 18, 1997;


13 IT WAS FURTHER ORDERED that the page limit previously imposed by the court
