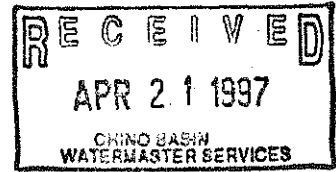



19 The Agricultural Pool of the Chino Basin judgment supports  
20 and joins in the Motion to Strike the Motion to Appoint Judge  
21 Turner as Interim Watermaster. The motion suggests the Advisory  
22 Committee motion to appoint Judge Turner as Interim Watermaster  
23 was approved by a 91.43% majority pool vote. The meeting was  
24 held without adequate notice to members of the Agricultural Pool  
25 and only representatives of the State of California appeared at  
26 the hearing on behalf of the Agricultural Pool and the vote  
27 constituted a voice majority vote and did not reflect the  
28 majority opinion of the Agricultural Pool.

1           The Notice of Motion and Memorandum of Points and  
2 Authorities filed by Monte Vista Water District are incorporated  
3 herein by this reference. The Agricultural Pool urges this court  
4 to not reconsider its determination and ruling that Chino Basin  
5 Municipal Water Company shall act as interim watermaster pending  
6 determination by Ms. Ann Snyder, Special Master.
