1 Notice of the February 20, 2002 hearing was mailed to the parties on January 31, 2002.
2 This is only five days outside the normal notice period. The parties who are directly involved in
3 the matters to be heard at the hearing were notified of the hearing date well in advance of this
4 date because, as is the recent practice with Watermaster matters, the pleading that has been filed
5 for this hearing is the product of a consensus negotiation of the parties. The pleading was
6 distributed to the attorneys for the parties in mid-January and a copy was distributed and
7 discussed at the January 24, 2002 Watermaster Advisory Committee and Board Meetings. No
8 objections have been filed regarding this motion and no party has objected to the occurrence of
9 the hearing on February 20, 2002.

10 Notice of the February 28, 2002 hearing was also mailed to the parties on January 31,
11 2002. This time is within the required notice period. However, subsequent to this, the hearing
12 time was changed from 2:00 to 11:00. Most of the parties received informal notice of this
13 change from Watermaster since the time change required Watermaster to change the time for
14 the Advisory Committee and Board meetings. Formal notice of the change was mailed to the
15 parties as a whole on February 7, 2002. No party has objected to this change.
