**WATERMASTER'S RESPONSE TO THE
COURT'S ORDER CONTINUING 12/18/15
HEARING AND CONFIRMATION OF
FILINGS THROUGH CHINO BASIN
WATERMASTER**

Chino Basin Watermaster (Watermaster) files this proposed briefing schedule in response to the Court's December 2, 2015 Order Continuing 12/18/15 Hearing and Confirmation of Filings through Chino Basin Watermaster. Watermaster does not oppose the Court's continuance of the hearing. However, given that parties have already had more than six weeks to prepare any pleadings responsive to Watermaster's Motion Regarding 2015 Safe Yield Reset Agreement, Amendment of Restated Judgment, Paragraph 6 ("Safe Yield Reset Motion:"), which is already on file, Watermaster anticipates that, absent an agreed briefing schedule, one or more parties may object to the Court's December 2, 2015 Order; request competing briefing schedules, or seek further clarification from the Court. (See Declaration of Scott S. Slater in Support of Watermaster's Response to the Court's Order Continuing 12/18/15 Hearing and Confirmation of

1 Filings through Chino Basin Watermaster (hereafter "Slater Decl.") at ¶ 8.) Therefore, for the
2 convenience of the Court, Watermaster is proposing the briefing schedule below for all matters
3 covered by the Court's December 2, 2015 Order, so all matters may be heard concurrently at the
4 January 22, 2016 hearing set by the Court.

5 The schedule set forth below has been circulated to counsel for many of the parties for
6 their input and consideration. (Slater Decl., at ¶ 10.) At this time, no party has agreed to stipulate
7 to the proposed schedule at the time of this filing, the City of Chino objects to the proposal, and it
8 is possible that some other parties may also oppose the proposal. (*Id.*) Notwithstanding the lack
9 of agreement, Watermaster believes it to be a fair resolution of the parties' varying positions.
10 (Slater Decl., at ¶ 11.) Accordingly, Watermaster respectfully requests that the Court order the
11 following briefing schedule:

12 1. Any new motions to be heard on January 22, 2016, as well as any opposition or
13 other pleading responsive to Watermaster's Safe Yield Reset Motion, will be filed with
14 Watermaster for filing with the Court and service on the Parties on or before **4:00 pm on**
15 **December 21, 2015.**

16 2. Oppositions to any motion filed by the December 21, 2015 deadline, above, will
17 be filed with Watermaster for filing with the Court and service on the Parties on or before **4:00**
18 **pm on January 7, 2016.**


19 3. Replies to oppositions to any motion to be heard at the January 22, 2016 hearing
20 (including any new motions and Watermaster's pending Safe Yield Reset Motion) will be filed
21 with Watermaster for filing with the Court and service on the Parties on or before **4:00 pm on**
22 **January 14, 2016.**

23 Watermaster believes a December 21, 2015 deadline for oppositions to its Safe Yield
24 Reset Motion -- filed on October 23, 2015 --fairly balances the desires of the parties intending to
25 file oppositions to Watermaster's Safe Yield Reset Motion to have reasonable time to prepare and
26 file their papers with the desires of those that may wish to both respond to any new motion and an
27 opposition to Watermaster Safe Yield Reset Motion. By using the opposition filing deadline of
28 December 21, 2015, parties will have had eight weeks to prepare their pleadings and two weeks

1 following the deadline for oppositions had the hearing been held on December 18, 2015, as
2 originally scheduled (Code Civ. Proc., § 1005, subd. (b)). Likewise, setting the filing deadline on
3 December 21, 2015, and in consideration of the holidays, will also give parties a reasonable
4 amount of time to prepare their replies. No party would be deemed to have waived any rights or
5 oppositions by the Court's ordering of this briefing schedule.

23 I, Scott S. Slater, declare:

24 1. I am an attorney duly admitted to practice before all of the courts of this State, and
25 am a shareholder in the law firm of Brownstein Hyatt Farber Schreck, LLP, and counsel of record
26 for Chino Basin Watermaster ("Watermaster"). I have personal knowledge of the facts stated in
27 this declaration, except where stated on information and belief, and if called as a witness, I could
28 and would competently testify to them under oath. I make this declaration in support of the

1 above-referenced filing.

2 2. On September 24, 2015, the Chino Basin Watermaster Board adopted Resolution
3 2015-06, which directed Watermaster legal counsel to prepare and file a motion with the Court
4 transmitting Resolution 2015-06, the 2015 Safe Yield Reset Agreement, and the referenced
5 Attachments to the Court, and, in accordance with the requests by the parties thereto, the advice
6 and counsel of the Pools, and the Advisory Committee, recommending that the Court approve the
7 proposed Judgment Amendment resetting the Basin's Safe Yield and to further order that
8 Watermaster proceed to further comply with the 2015 Safe Yield Reset Agreement.

9 3. On October 23, 2015, Watermaster filed and served on the Parties its Motion
10 regarding 2015 Safe Yield Reset Agreement, Amendment of Restated Judgment, Paragraph 6
11 ("Safe Yield Reset Motion"). Prior to filing the Safe Yield Reset Motion, Watermaster had
12 secured with the Court a hearing date for the Motion of December 18, 2015, at 1:30 pm.

13 4. On December 2, 2015, the Court, upon its own motion after inquiry from the City
14 of Chino as to ex parte applications for continuance of the December 18, 2105 hearing date and to
15 file a Motion to Re-Open Discovery, continued the hearing to January 22, 2015.

16 5. The Court's December 2, 2015 Order did not suggest a briefing schedule and did
17 not state the time in which any oppositions to Watermaster's pending Safe Yield Reset Motion
18 must be filed. We received inquiries from several parties inquiring as to the date oppositions
19 must be filed and whether the date to file oppositions had been extended along with the hearing
20 date.

21 6. On December 4, 2015 and then frequently between December 7, 2015 and
22 December 11, 2015, I had discussions with counsel for some of the Parties and Pools to the
23 Judgment, among them some that have approved and executed the 2015 Safe Yield Reset
24 Agreement, and some that have not.

25 7. Counsel for the Parties with whom I have spoken are not of the same opinion as to
26 the required filing deadlines and, in my opinion, are likely to seek clarification from the Court.

27 8. Based on my discussions with counsel for the parties, it is my belief that, absent an
28 agreed briefing schedule, one or more parties will object to the Court's December 2, 2015 Order;


1 request competing briefing schedules, or seek further clarification from the Court.

2 9. On December 7, 2015 and December 9, 2015, I communicated by telephone and
3 via e-mail with counsel for the City of Chino (the City) and the Jurupa Community Services
4 District (Jurupa CSD) regarding the possibility of a briefing schedule in anticipation of the
5 January 22, 2016 hearing similar to that proposed in Watermaster's Response to the Court's
6 Order Continuing 12/18/15 Hearing and Confirmation of Filings Through Chino Basin
7 Watermaster. Counsel for the City and Jurupa CSD indicated to me that they did not wish to have
8 the Court set a deadline for any oppositions to Watermaster's Safe Yield Reset Motion other than
9 on the same date as the deadline for oppositions to any other motion that will be heard by the
10 Court at the January 22, 2016 hearing.

11 10. We prepared a proposed briefing schedule, as shown in Watermaster's Response
12 to the Court's Order Continuing 12/18/15 Hearing and Confirmation of Filings through Chino
13 Basin Watermaster and circulated it to the parties on Wednesday December 9, 2015. As of the
14 date of this declaration, no Party has agreed to the schedule, and the City of Chino has indicated
15 that it is opposed to it.

16 11. Nonetheless, we are recommending the briefing schedule included in
17 Watermaster's Response to the Court's Order Continuing 12/18/15 Hearing and Confirmation of
18 Filings through Chino Basin Watermaster as a basis for fairly balancing the concerns of preparing
19 an Opposition for a motion filed six weeks ago and the concerns of parties having to reply to an
20 opposition that has been six weeks in preparation.

21 I declare under penalty of perjury under the laws of the State of California that the
