#### What is a Watermaster?

- Employee of a court hired to administer a court decree.
- One who allocates the right to use water from a specific source.
- Special master with unique qualifications or subject matter expertise.
- May be imposed by judicial order or stipulation among parties and judicial approval.



### Origin of CBWM

- Chino Basin Judgment was created by stipulation (contract).
- 1st Watermaster appointment was to the Chino Basin Municipal Water District (CBMWD) now IEUA.
- CBMWD was replaced on motion of the parties and by order of the Court.
- The 9 member board serves at the pleasure of the Court.



#### Characteristics of Watermaster

- Extension of the Court.
- Not a public agency; no Public Records and Brown Act.
- Not subject to CEQA.
- Decree preempts conflicting local agency / city / county regulation and binds all parties regarding the subject matter (Chino Basin).
- Makes findings of fact and makes recommendations to the Court for the administration of the decree.

## Shared Governance / Prescribed Powers

- By stipulation, the 3 Pools, the Advisory Committee and the Board comprise Watermaster.
- The Watermaster Board possesses the prescribed discretionary powers embodied in the decree and as provided by further stipulation and Court order.
- The question of continuing jurisdiction and organic discretionary authority Article X, Section 2.



#### Role of Pools

- Each of the Pools has the right and opportunity to provide advice and counsel to the Advisory Committee and the Watermaster Board.
- Each member of each Pool has the right to request Watermaster action or review on matters within the subject matter jurisdiction of Watermaster.



### Role of Advisory Committee

- To provide advice and counsel to the Board.
- To mandate certain actions by the Board where 80% or more of stakeholders are in agreement.
- To establish a budget and control expenditures.
- To represent the production rights of the Basin in accordance with their relative stakes.

## Role of the Board: Administer the Decree

- Pursuant to the Judgment, the Peace Agreement and its progeny, and continuing orders of the Court, the 9-Member Board administers the decree and implements the physical solution.
- All of its actions and authorities are prescribed and limited by these same instruments.

## Advisory Committee / Board Interface

- Advice and Counsel. The Board must consider a recommendation from the AC but unless there is an 80 percent or greater mandate from the AC, the Board may elect to disregard the recommendation by providing notification and opportunity to be heard and supported by a written decision.
- Mandate. In the event of an 80 percent mandate, the Board must either: (a) approve; (b) return to the AC for clarification or request for revision; or (c) challenge the decision before the judge.

# Hypothetical #1: Adoption of Budget

- Watermaster submits a proposed budget and recommendations to Advisory Committee.
- Pools make recommendations and Advisory
   Committee takes action <u>by 80 or more volumetric vote.</u>
- Must the Board must adopt the budget?
- May the Board adopt the budget as submitted but then transfer 10 percent of the administrative budget from one expense to another provided that the total budget is not exceeded?

## Hypothetical #2: Engagement of Information Consultant

- Mid-fiscal year, the Board identifies a new consultant requirement to complete a defined OBMP task.
- Two of the Pools recommend against the consultant.
- The Advisory Committee is 60/40 in favor of the retaining the consultant.
- There is no fiscal impact to retain the consultant as other Watermaster expenses have been less than budget in amount greater than the new consultant contract.
- May the Board retain the consultant?



#### GM Role

- Receives direction from and is responsible to the Watermaster Board
- Responsible for all matters pertaining to the administration and operations of the Basin under the provisions of the OBMP Implementation Plan
- Ensure compliance with the Judgment; Peace Agreements; Court mandates
- Day-to-day leadership of Watermaster



#### **AGM** Role

- Assessment Package Preparation
- Annual Report Development
- Supervise Ops Staff
- Data Requests
- Water Transfer (and other) Transactions
- Groundwater Recharge Coordination and Development
- Consultant Management Report/Permit Review
- Interagency Agreement/Permit Management
- Regional Water Resources/Quality/Contamination Coordination



#### CFO Role

- Accounting/Financial Reporting
- Budgeting/Treasury Operations
- Human Resources
- IT Services
- Risk Management
- Administration



#### Staff Functions-Consultants

- General Counsel Role
  - Reports to the Board
  - Provides legal services necessary for Watermaster function
  - Assists GM and staff as necessary in carrying out tasks
- WEI Role
  - Receives direction from staff
  - Performs various tasks including technical analysis, data gathering, report preparation



#### Staff Functions-External Agencies

- IEUA
  - Coordination on recharge operations
  - Recharge facilities maintenance cost share
  - Improvement project management and cost share
  - Hydraulic Control cost share
  - Storage and Recovery programs

#### Peace Agreement

- 30/60 Year Agreement on Basin Management Strategies.
- Ministerial Active Short Term and Long Term Transfers Provided There is No Harm.
- 500,000 AF of Total Storage.
- Ministerial Local Storage Agreements Provided There is No Harm.
- Storage and Recovery Authorization.



### Peace Agreement Continued

- Early Transfer of Ag Surplus to App Pool.
- Orderly Land Use Conversion.
- Yield Preservation.
- OBMP Implementation Plan.
- 30 MGD of Desalting Capacity.
- Recharge Improvements (Stormwater; Basin Balance, Arrest Subsidence).
- Conflict Avoidance



#### Peace Agreement Implementation

- 100,000's of AF transferred.
- 100,000's of AF stored pursuant to Local Storage Agreements.
- MWD Dry-Year Yield Storage and Recovery Agreement.
- 30 MGD of desalting capacity physically constructed and fully operational.
- Wet Water Recharge, Arrest Subsidence, Stormwater
- No opposition to Watermaster approval, environmental review or implementation.



### Peace Agreement 2

- Enhanced Management Plan Strategy.
- Authorization of 10 MGD of desalting capacity (40 total).
- Appropriate 400,000 AF of water.
- Enhance recycled water use.
- Safe Yield Preservation Santa Ana River Inflow
- Redistribute 40,000 AF of stranded Non-Ag water to App Pool.
- Continued Conflict Avoidance.



### Peace 2 Implementation

- Successful Implementation of All Measures
- Recharge Master Plan: WIP



#### **Cumulative Economic Benefits**

- Values spread among parties to the Judgment.
- Public grants and contribution towards infrastructure projects.
- Storage comps \$1,500 per AF.
- Yield preservation.
- Litigation and Lost Opportunity Costs Avoided.
- Cumulative Benefits Greater Than \$1 Billion.

- Safe Yield Recalculation
- City of Fontana Motion
- RMPU Implementation



#### Safe Yield Recalculation

- Required by the OBMP Implementation Plan
- No impact on overlying land owners rights (Ag and Non Ag); possibly lower production rights for Appropriators
- Recalculation, pursuant to OBMP Implementation Plan and Rules and Regulations, has been done and is being presented/explained to Parties
- Assisting Parties to offer advice and recommendations to the Board



#### City of Fontana Motion

- Challenged Section 5 of the 2013 Amendment to the 2010 Recharge Master Plan Update: City believes a sentence regarding credit for recharge from MS4 permit compliance that was in 2010 RMPU must be included in 2013 Amendment
- Stipulation allowed Court approval of the RMPU Amendment minus Section 5, and initiated a facilitated discussion among City and Appropriators
- Scheduled for Court hearing in April; City withdrew from facilitated discussion



#### RMPU Implementation

- Appropriators and IEUA agreed to implement a number of projects; CBWCD will consider funding some.
- IEUA is leading the projects; Watermaster is coordinating overall RMPU implementation
- Various contracts will be coming to the Board for consideration
