Texchded Pero Sp. 3 RESOLUTION OF THE CHINO BASIN WATERMASTER, SAN BERNARDINO COUNTY, CALIFORNIA, ESTABLISHING PROCEDURE FOR CALCULATING AND TRANSFERRING UNALLOCATED SAFE YIELD WATER

WHEREAS, the Judgment in the Chino Basin Adjudication, Chino Basin Municipal Water District vs. City of Chino, et al., San Bernardino Superior Court No. 164327, at Paragraph 44 and Exhibit "I" thereof, provides for re-allocation of Unallocated Safe Yield water; and

WHEREAS, the provisions of said Paragraph and Exhibit are in need of interpretation as to operationthereof and calculation thereunder; and

WHEREAS, it is the desire of the parties to the Judgment to memorialize their agreement and understanding, by and through their respective Pool Committees, regarding the calculation and trasnfer of Unallocated Safe Yield water.

NOW, THEREFORE, IT IS HEREBY RESOLVED AND DETERMINED that all transfers and calculations of Unallocated Safe Yield water shall be made in accordance with the procedure and calculations herein set forth, to wit:

- Watermaster shall determine the Overlying (Agricultural) Pool's total production in any applicable five (5) consecutive year period.
- 2. The Overlying (Agricultural) Pool's production as determined in Step 1. above shall be subtracted from the Overlying (Agricultural) Pool's production right of 414,000 acre feet in any five (5) consecutive year period.
 - The amount determined in Step 2. shall be divided by five (5).
- The amount determined in Step 3. shall be available for transfer to the Appropriative Pool as a supplement to that Pool's right

of production (Operating Safe Yield) for production in the year inmediately following the five (5) year production period that was the basis of the calculation of the Overlying (Agricultural) Pool's production set forth in Step 1. above.

By way of production, the calculations set forth in Exhibit "A", attached hereto and made a part hereof, may be used as a guide in making the calculations and transfers pursuant to this Resolution.

This Resolution shall become effective upon adoption by all the Pool Committees and the Advisory Committee and may be applied retroactively to determine prior Unallocated Safe Yield production rights of the Appropriative Pool.
