WHEREAS, Article 2, paragraph 2.03, page 4 of said Watermaster Rules and Regulations as approved and adopted on March 20, 1978, provide that regular meetings of Watermaster shall be held on each fifth Wednesday, and

WHEREAS, it is in the best interest of Watermaster to change said regular meeting time and day.

THEREFORE, BE IT RESOLVED that said Article 2, paragraph 2.03, page 4 of the Watermaster Rules and Regulations shall be revised to read as follows:

2.03 Regular Meetings. Regular meetings shall be held at the principal office at 8:30 a.m. on the first Wednesday following each fifth Wednesday, or at such other time or place as may be designated from time to time by the Watermaster, contained in the necessary notice thereof. the time designated for regular meetings shall fall on a legal holiday, the regular meeting shall be held instead on the next succeeding regular business day at the same time and place, or such other day, time and place as may be designated.
