

RESOLUTION 91-2

A RESOLUTION OF THE CHINO BASIN WATERMASTERS
LEVYING A SPECIAL ASSESSMENT FOR THE
CHINO BASIN WATER RESOURCE STUDY
FOR FISCAL YEAR 1991-92


WHEREAS, the Chino Basin Watermaster was appointed on January 27, 1978, under Case No. 164327 entitled Chino Basin Municipal Water District v. City of Chino, et al., with powers to levy and collect administrative and replenishment assessments necessary to maintain water levels and to cover the cost of administration of the Chino Basin Groundwater Basin Management Plan; and

WHEREAS, the Chino Basin Watermaster has approved a special assessment for the Chino Basin Water Resource Study as recommended by the Watermaster Advisory Committee for Fiscal Year 1991-92 in the amount of \$400,000.

NOW THEREFORE, BE IT RESOLVED that the Chino Basin Watermaster levies the respective assessments for each agency for each various pools as recommended by the Watermaster Advisory Committee as shown on Exhibits "A" and "B" attached hereto.




