## RESOLUTION OF THE CHINO BASIN WATERMASTER AGRICULTURAL POOL ESTABLISHING SUPPORT FOR A ALTERNATIVE METHOD TO MITIGATE THE EXISTING PRACTICE OF SPREADING MANURE IN THE CHINO GROUNDWATER BASIN

WHEREAS, there is an urgent need to prevent the further degradation of the Chino Groundwater Basin, as a result of the existing practice of manure spreading; and

WHEREAS, there is a need for a reliable method of disposing of said manure; and

WHEREAS, the Agricultural Pool members desire to declare support for a method to dispose of existing manure; and

WHEREAS, the Agricultural Pool members declare that they support mitigation through a Co-composting facility to handle manure or hauling of manure from the Chino Basin or a combination of both.

NOW, THEREFORE, the Chino Basin Watermaster Agricultural Pool members do hereby DETERMINE, RESOLVE AND ORDER as follows:

Section One: That it will support mitigation efforts that reduce the existing practice of spreading manure in the Chino Groundwater Basin including a Co-composting facility or hauling of manure from the Chino Groundwater Basin, or a combination of both.

Section Two: That the Secretary is hereby authorized and directed to transmit certified copies of this resolution to the appropriate agencies.
