Section 1. Depository Agreements. That John L. Anderson, as Secretary/Treasurer of Chino Basin Watermaster, is hereby authorized to enter into and execute agreements for deposit of Watermaster funds in bank accounts, pursuant to Section 53630 of the Government Code.

Section 2. Depository Cards. That the persons authorized and directed to execute depository cards for all bank accounts of Chino Basin Watermaster are designated as follows:

Section 3. Signing of Checks. That checks of the Chino Basin Watermaster may be signed by certain persons as follows:

- a) Any check up to \$10,000 may be signed by any one (1) person under Section 2, or with the facsimile signature of the Secretary/Treasurer.
- b) Any check in excess of \$10,000 may be signed by any (2) signatories listed under Section 2, or one (1) signatory listed under Section 2 and the facsimile signature of the Secretary/Treasurer.

Section 4. Intrabank Transfers. That written authorization to transfer funds between the Watermaster checking account and savings account may be signed by any person listed under Section 2, or in the absence of those listed thereon, by the District's Manager of Accounting.

Section 5. Newly issued Time Certificates of Deposit. That any District Officer listed under Section 2, or in the absence of those listed thereon, the District's Manager of Accounting, may sign receipts for "Notices to Depository-Penalty for Early Withdrawal of Time Deposit" covering new Time Certificates of Deposits issued to the Chino Basin Watermaster.

Section 6. Maturing Time Certificates of Deposit. That any District Officer listed under Section 2, or in the absence of those listed thereon, the District's Accounting Manager, may endorse a maturing Certificate of Deposit when such an endorsement is required by the issuing financial institution at redemption.

Section 7. Rescission of Resolution. Upon adoption of this resolution, Resolution No. 78-4 is hereby rescinded in its entirety.
